1. Tender will be received by speed post/register post/Courier Service only in sealed cover address to the Managing Director, Tripura Tea Development Corporation Ltd. Lake Chowmuhani, Agartala West Tripura, Pin-799001 up to 3.00 PM on 18/04/2017 and shall be opened on the same day, if possible.
2. The tentative annual requirement of coal (ROM) 500 MT (Approx) of size 1/2" (Half inch)
3. Tender will be entertained by post provided those reach on or before 3.00 PM on the date mentioned herein above.
4. The rate should be quoted both in figure and words separately on weight (in MT) as well as volume (in cubic feet) basis inclusive of all taxes, Duty, Surcharge etc. delivery CTPF Durgabari.
5. Tenders should be accompanied by Earnest Money Deposit (EMD) of Rs.1.00 (Rupees One lakh) only as "Deposit at Call" pledged in favour of Tripura Tea Development Corporation Ltd. Agartala. EMD of un-successful tenderers will be released within 3 (three) days from the date of issue of supply order, if possible.
