**Details of Terms and Conditions for Agency Agreement with TSIC Ltd. for "Nodal Agency" under New Coal Distribution Policy 2007.**

**Part - I**

- The Agency shall have sufficient other resources as required for the business and specified by TSIC Ltd. The Partner shall also have reputation in managerial skills in the concerned or similar areas of activity.
- Credentials shall be supported by documents like Registrations, Licenses, Profit and Loss Account, Balance Sheet, Income Tax returns, GST registration, Bank Statement etc. for the last five years as applicable.
- Details of existing organizational set-up with bio-data of the partners/promoters and key- personnel of the Company/ Firm to be provided.
- The Company/Firm shall be in operation/business with profit in similar activities at least for 5 (five) years. Company/Firm already in business with Government/PSUs as agency will be given preference.
- The TSICL will be involved mainly in policy decision and receive the coal from Coal India Ltd. against the State quota from the coal fields. Purchase, transportation, distribution and selling of coal to approved buyers will be responsibility of the Agency.
- The Agency shall submit a Conceptual Business Plan indicating available infrastructural facilities or to be created for setting up of the distribution point (including built up area), storage facilities at Dharmanagar, Kumarghat, Ambassa, Agartala, Udaipur and Santirbazar. A soft copy of the proposal in CD may also be submitted.
- The Agency shall also submit a logistic plan for transportation of coal from fields up to the distribution points including modalities for availing of railway racks /wagons/trucks in sufficient number.
- The Selling Price of Coal ex-depot shall be finalized by the Government of Tripura or by an Advisory Committee representing all stakes -holder

- (i) The Agency shall also deposit a sum of Rs. 5000 (Five thousand) only as non-refundable Processing Fees in the form of Bank draft/Bankers Cheque in favour of "Tripura Small Industries Corporation Limited".
- (ii) The selected bidder shall be required to sign an Agreement with TSIC Ltd. The Agreement will be registered at the expenses of the Agency.
- (iii) The selected Agency will be also required to deposit Rs. 25.00 (Twenty five) lakhs as Security Deposit in the form of Bank Guarantee to TSIC Ltd. for the entire period of Agreement before signing of Agreement.
