NB. Essential Qualification for All Trades as mentioned above: CITS course in relevant trades under NCVT for both Diploma & Degree holders, failing which CITS course will be relaxed at the time of selection of the candidates, but the selected candidates must clear CITS within 3(three) years after appointment to the post and the cost of CITS training will be borne by the candidates itself. In case of non-completion of CITS Course within stipulated period, the appointment shall be terminated

2. **Age:** Up to 40 years as on date of submission of application. Upper age limit is relaxable by 5 years for SC/ST/PH and Government servant provided that Government employees belonging to SC/ST/PH category will not get relaxation over and above general relaxation of 5 years available to them. Upper age limit is also relaxable for ex-serviceman as per norms.

4. **Selection procedure of Senior Instructor, ITI, Group-C (Non-Gazetted)**

- (a). The selection procedure will be governed as per relevant Recruitment Rules and Syllabus of the post of Senior Instructor, ITI, Group-C (Non-Gazetted) both Engineering and Non-Engineering Trade Notified vide No. F. DI/ESTT/1-132000/6651-704 dated 4th June, 2021 and No. F. DI/ESTT/1-21/2009/18655-79 dated 31-12-2021.

- (b). **Scheme of Written Examination:** The written examination will consist of one paper viz. a paper on "General Studies and Engineering Aptitude". The paper will be of an objective type consisting of 170 multiple choice questions. The paper will carry 170 marks and will be of Two-and-a-half-hour duration. The paper consists of two parts, namely (i) Part-A General Studies (50 questions of 01 marks each) (ii) Part-B "Engineering Aptitude" (120 question of 01 marks each). There will be Negative marks for MCQ. For each question for which a wrong answer has been given by the candidate, one-fourth of the marks assigned to that question will be deducted as penalty.

Interview cum Personally test: A limit number of candidates, maximum 5(five) times of total posts (in category wise) will be selected merit wise on the basis of the result of the written examination, subject to securing minimum qualifying marks (50% for UR candidate, 45% for Scheduled Caste candidate & 40% for Scheduled Tribes category candidate) OR other wise as fixed by the departmental selection committee. The total marks for the personally test will be 30(thirty). If a candidate remains absent in the personality test, his/her candidature will be treated as canceled. Final merit list will be prepared on the basis of the total marks obtained in the written examination & personality test.

The paper consists of two parts, namely (i) Part-A General Knowledge and Current Affairs (50 questions of 01 marks each) (ii) Part-B "Trade/ Subject Aptitude" (120 question of 01 marks each). There will be Negative marks for MCQ. For each question for which a wrong answer has been given by the candidate, one-fourth of the marks assigned to that question will be deducted as penalty.

Interview cum Personally test: A limited number of candidates, maximum 5(five) times of total posts (in category wise) will be selected merit wise on the basis of the result of the written examination, subject to securing minimum qualifying marks (50% for UR candidate, 45% for Scheduled Caste candidate & 40% for Scheduled Tribes category candidate) OR other wise as fixed by the departmental selection committee. 

- (d). **Verification of Certificates/Documents:** After publication of result of written examination, successful candidates will be asked to submit self attested copies of the relevant documents i.e Age Proof Certificate (DOB/Admit Card of Madhyamik), Educational Qualifications (Madhyamik onwards), Mark sheet and Certificates, Scheduled Cast/ Scheduled Tribe/PH/Ex-SM Certificate (if any), PRTC, Experience Certificate(s) from appropriate authority with mention of designation, type of work experience, joining date end date, etc. for verification purpose.
- (e). On scrutiny of the documents, if a candidate is found ineligible as per terms and condition of the advertisement (**Prescribed recruitment fees**), his/her candidature will be rejected. For in service candidate, if the application is not routed through proper channel at the day of interview candidates will have to submit "**No-objection**" certificate failing which his/her candidature will not be considered for preparation of final merit list. In that no objection certificate, it is to be clearly mentioned that your employer has "**No-objection**", if you are considered for recruitment to the post for which you have applied for.
