Subject: Submission of application for Incentive Eligibility Certificate, subsidy claims by the industrial enterprises and subsequent processing of the same by GM, District Industries Centre under Tripura Industrial Investment Promotion Incentive Scheme (TIIPIS), 2022.

Whereas, the Government of Tripura, in the Department of Industries and Commerce has introduced a new State Incentive Scheme called "Tripura Industrial Investment Promotion Incentive Scheme (TIIPIS), 2022" for the industrial enterprises to be set up in the State of Tripura w.e.f. 1st April, 2022 for 5 years.

Whereas, as per the operational guidelines of the Scheme-2022, application for Incentive Eligibility Certificate and subsidy claims under various components of subsidies by the industrial units and subsequent processing of the claims at DIC as well as at Directorate level is required to be processed in online mode through "SWAAGAT PORTAL".


Whereas, the development of the State e-portal for State Incentive scheme under SWAAGAT Portal is under preparation and require additional time to complete the process.

Whereas, as per the guideline of the scheme, subsidy claims have to be submitted within the period of one year from the date of commencement of commercial production and thus, few of the industrial units may be eligible for submission of claims within the stipulated time period prior to launching of the e-portal for use.

Now, therefore, it is hereby decided that the industrial enterprises approaching to District Industries Centres for Incentive Eligibility Certificate and submission of subsidy/ incentive claims under State Incentive Scheme,2022 shall be allowed to submit their claims to the GM, DIC

concerned and subsequent processing of the claims by DICs as well as at Directorate level shall process the claims in **offline mode** until the State e-portal for State Incentive Scheme under SWAAGAT Portal is kept in force for use of the entrepreneurs as well as the officials of the Department.
